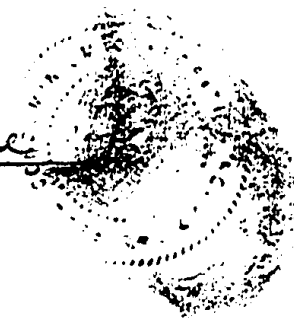

PEEL CONDOMINIUM CORPORATION NO. 27
SPECIAL BY-LAW NO. 3

BE IT ENACTED as a by-law of Peel Condominium Corporation No. 27 (hereinafter referred to as the "Corporation") as follows:

That the Corporation enter into a gas service easement agreement with The Consumers' Gas Company Ltd. (hereinafter called the "Gas Company"), for the purpose of granting the Gas Company a right, license and easement over the common elements of the Corporation in order to facilitate the Gas Company's ability to install, maintain, repair, replace and operate the Gas Company's gas lines situate thereon and thereunder.

That the President or Secretary of the Corporation be and he is hereby authorized to execute the Gas Agreement on behalf of the Corporation, together with all the other documents and instruments which are ancillary thereto (with or without the corporate seal of the Corporation affixed thereto), including without limitation, all instruments, applications and/or affidavits which may be required in order to register the Gas Agreement (and any transfer or conveyance or easements) against the title to the condominium property and/or adjacent lands, if so required or desired by the Gas Company. The affixation of the corporate seal of the Corporation to all such documents and instruments is hereby authorized, ratified, sanctioned and confirmed.

The foregoing by-law is hereby enacted as ^{Special} By-Law No. 3 of Peel Condominium Corporation No. 27.
